UNUSED WEEKS DUE TO COVID 19

The Committee are aware of the frustration and disappointment of members who have been unable to use their weeks due to the closure of the resort, caused by the Government restrictions due to Covid 19 pandemic over this past year.

After much discussion, the Committee decided that, despite there being no Constitutional requirement to do so, a week(s) in-lieu will be offered to members who were unable to use their weeks during the shutdown period. As you are aware, there were two enforced closure periods and the second of these further disrupted some members using the alternative weeks offered as the result of the first lockdown. It is now envisaged that alternative weeks will be offered for the remainder of 2021 and into the first quarter of 2022 for all those who were unable to use their weeks over the shutdown periods.

Members are asked to make regular checks on the members section of the website for updates on the opening dates and conditions from the time that the government allows UK holiday restrictions to be lifted
